# Director's Reports:

- Vice President: N/A
- **Registrar:** Spring Flag registration scheduled to open Feb. 10; not a "wait list" set up; simplified insurance payment portion of registration, best it will be, 2 payments.
- **Treasurer:** \$19 445.38 Operations; \$113 net income after equipment spend Application for gaming grant to be submitted @ end of month; 2015 actual income was \$26,687; 2016 budget estimated for \$28,000, it was actually

\$43,125; with excess net income should we discuss the possibility of dropping registration fees; offer rebate? Multi-player grants?

(Mike I.) We need to consider the audit we went through; need to keep separation on costs for each program (tackle equp; vs no equip for flag); Need to consider that we are one umbrella - KMFA profits from flag can offset losses in winter flag;

2017 budget can be presented at next meeting

- **Director of Flag:** Winter: 4 weeks left; 78 kids; target was 96; efficient method to make teams; but we always fall short of even playing field somehow; Dean recommends letting coaches pick the teams so people don't blame KMFA

Spring: 2 transactions for registration if your new coming into spring;

February 10<sup>th</sup> Registration opens; proposing tiered system. \$190 reg fee, then March 10<sup>th</sup> fee is \$215 (insurance \$49);

Registration closes Mar 26 -following week to get organized

Evaluations Fri March 31st (U16/18); Saturday April 1st;

Last year registration was \$135/\$30 insurance fees; Price increase due to better quality shirts/shorts, new logo; Brandt – Sunday warm ups for Flag kids, Prime Physiotherapy logo on the back of shirts; 8 colours of shirts;

Volunteer fee - \$20; proposed to \$50 (just for flag)

Previous board goal: get bottom line in order to hold fees over or even reduce year over year

- Colin F. makes a motion to increase volunteer fee to \$50; second by Mike S.;

- Colin F. makes a motion to adopt new flag logo; second by Mike S. all in favour

- **Director of Equipment**: Still need more pants for tackle; Equipment room looks good
- Director of Coaches: met with highschool coaches for U16/18 Flag interest; suggesting a team fee as opposed to per player fee;
  - 69 responses for Tackle Coaching survey; good number of results, but more feedback is needed from our membership
- Director of Player Development: N/A
- Director of Communications: Newsletter needs to go out ASAP; mostly Flag centered; new board introduction; spring flag registration date; Girls only flag; U18; coaches clinic date;

NCCP coach clinic canceled this past Saturday, need minimum 8 registered; rescheduled for Apr. 22 – March newsletter item
